

MGA AFFIDAVIT OF FINANCIAL SUPPORT

Middle Georgia State University requires each applicant in *current* or *future* F-1 status to document their ability to fund the first full year of study in the amount of \$30,014\$ USD for undergraduates, \$29,052\$ USD for graduate (USD = U.S. Dollars). This amount reflects the *estimated* full cost of attendance for 1 year; including tuition and fees, room and board, health insurance, books, and other living expenses. Each amount is only an estimate for the 2024-2025 school year and all figures are subject to change without notice.
