## Admissions Package for Home School and Non-Accredited High School Applicants

The following items are necessary to compile an admissions package for home educated applicants and applicants who attended a non-accredited high school.

	Application for Admission and \$30 non-refundable application processing fee. (http://www.mga.edu/admissions)			
	Official SAT or ACT Scores are optional.  (applicable to traditional freshman only)			
	Official transcripts from any conventional public/private high school and all colleges attended.			
	Copy of Declaration of Intent to Homeschool as filed with local Board of Education. (for applicants under the age of 17)			
	Completed College Preparatory Credit Evaluation Form. (see page 3 of this handout)			
	Completed Course Credit Supplement indicating course work completed in each subject area with subject title, course description, texts used, and primary teacher.			
	Signed Certification Form. (see page 4 of this handout)			
	Letter from primary teacher certifying completion of high school and date of high school graduation.			
	Certificate of Immunization.			
	Lawful Presence Documentation.			
Your completed application packet should be submitted to the Office of Admissions at Middle Georgia State University prior to the deadline for the term for which you are applying. For students to be considered an on-time applicant, all admissions materials must be properly executed and submitted to the Office of Admissions at least four weeks prior to the beginning of the semester for which admission is sought.
