- a. <u>Update Data Elements and Data Definitions Workgroup (Boswell)</u> Work with Ana on getting the RevQ system added. On system request access new guidelines for webpage. Guidance on webpage has been added for when an employee leaves the institution. Please reach out to Boswell with any questions.
- b. Update Data Life Cycle:
 - Records Management Program Workgroup (Gibbons) Gibbons and Tsavatewa have worked with Rainey on updating her on records management. The RMP was approved in July and it will go on the webpage soon where all policies are being streamlined.
- c. Update Data Quality Control (Gibbons)
 - Data Collection and Reporting Calendar July 31st Final Deadline Gibbons said progress hasn't been made in the last quarter, but there is still time to do it before the deadline. He noted this is an important item needed and it will get done.
- d. <u>Update Data User Training (Stanley)</u> 667 out of 1272 (53%) have taken training as of 11/30/21 and then training was closed. Training will reopen in January. Please reach out to those in your area that need to take the training and stress the importance of it.

There are consent forms that are required when we gather information on individuals. Dian Mitchell is working on those (she spoke to Rose at USG and she said the form has to have some type of acknowledgement). Mitchell believes we will be able to complete on time. Morgan is working on the ones for Tier 2 and 3. He will be adding notification to MGA website about privacy. MGA is modeling from the data privacy and legal notice from the USG version.
