The Office of Student Financial Aid will electronically submit the HOPE Scholarship/Zell Miller Scholarship Eligibility for Transient Study form to the institution you plan to attend. This form will authorize the transient institution to award HOPE or Zell Miller Scholarship to you.

When the term ends, it will be your responsibility to request an official academic transcript from the transient institution. It should be sent to the Registrar's Office at Middle Georgia State University(MGA). The hours you attempt at the transient institution will be used to determine your continued eligibility for the HOPE or Zell Miller Scholarship at MGA.

If you are awarded Hope and/or Zell Miller Scholarship to attend MGA the semester after your transient studies, the funds will be disbursed even if the academic transcript has not arrived from the transient institution, because of the brief amount of time between semesters. However, HOPE and/or Zell Miller for subsequent terms will be canceled if the academic transcript has not arrived by mid-term of the semester after your transient studies. If the hours you attempt as a transient student bring you to a checkpoint (30, 60, or 90 attempted semester hours), and you do not have a HOPE Scholarship cumulative GPA of 3.0 or better, or Zell Miller GPA of 3.3, you will be required to repay any HOPE and/or Zell Miller Scholarship funds disbursed to your student account.
