For HLSA 3360, of the 16 students completing the Individual Research Project, 15 students (94%) mastered the assessment. For HLSA 4100, all 4 of the students (100%) were successful in mastering the Final exam. For HLSA 4410; of the 24 students completing the Final Exam; 22 students (92%) mastered the assessment. For HLSA 4470; of the 45 enrolled students, 41 completed (91%) the Final Assessment. Of the 34 students enrolled in HLSA 4480, 33 (94%) mastered the final assessment.
