Having the lowest tuition in the state does not appear to impact enrollment.</p> <p>A couple of changes have already taken place. Fiscal Affairs, Academic Affairs and Dean Underwood crafted an agreement with Coliseum Health Systems that offers their employees a discounted rate for the RN-BSN Completion Program.</p> <p>At the present time, the RN-BSN Program Coordinator, Dr. Wilbur is preparing an 8 week / course curriculum for the 5 RN-BSN courses.</p> <p>Following Academic Affairs approval, the proposed change will require accreditation and governing body approval.</p> <p>MGA's Marketing Department is increasing the marketing efforts for this program with added billboard visibility in prime locations.</p>

	<p>The re-entry policy for the RN-BSN Completion Program was modified and approved allowing a more easy return for RN-BSN who withdrew from classes secondary to life and/or career events.</p>
