What changes will you make based on this effort next year? | Housing/Res Life assesses retention at the beginning of every Fall and Spring semester but concentrates on the Spring to Fall numbers most. We had maintained a 65% retention rate or higher for every assessment cycle prior to FY18. This FY we did not reach that goal but did increase by 2%. Going forward we seek to increase Spring to Fall retention rates over the summer by following the Enrollment Action Team's efforts. |

We will look at these rates per campus to make sure that attendance rates in Macon and/or Eastman do not skew the overall rates for H/RL. We will also continue to look at this assessment internally. |

We will continue to get students to the meetings they need to be at in the residence halls and we will continue to offer programming that will be useful to them as students and as citizens.
