In the sample semester, there were four teams in the online section and six teams in the face-to-face semester. All of the teams in the online section achieved the Satisfactory or Exemplary levels (100%). Five of the six teams in the face-to-face section achieved the Satisfactory or Exemplary levels (83%). Although the assessment is based on teams, data is reported individually. In this case, the team that earned the Developing level was a team of five or 12% of class. Had this team been a team of four, the team result would still be 83% were at the Satisfactory or Exemplary levels but the individual numbers would be 82%. Given that this assessment is based on a team project and that 83% of the teams achieve the desired level, no additional action is required except to continue to monitor the class.</p>
