<p>Overall Use of Assessment Results for Continuous Improvement and Open Text Box For Assessment Comments:</p>	<p>The School of Computing has incredible and adaptable professional advisors and administrative staff that were a driving force in keeping students informed and registered.</p> <p>This past year, the response rate to the academic advisor assessment was low with only 8 students responding. We will immediately begin taking actions to increase the response rate – students will be reminded after each advising session to complete the survey. We will also send advisees a follow-up email asking them to complete the assessment. Lastly, we will place a sign outside of the advisor's office with a QR code linking to the advisor survey.</p>
